ISO 45001:2018 is applicable to any organization that wishes to establish, implement and maintain an OH&S management system to improve occupational health and safety, eliminate hazards and minimize OH&S risks (including system deficiencies), take advantage of OH&S opportunities, and address OH&S management system nonconformities associated with its activities.

ISO 450012018 helps an organization to achieve the intended outcomes of its OH&S management system.

Consistent with the organization's OH&S policy, the intended outcomes of an OH&S management system include:

ISO 22716 is an International standard of good manufacturing practices (GMP) for perfume, cosmetics, pharmaceutical & other manufacturing companies. It describes the basic principles of applying GMP in a facility that produces finished products.

Operating costs drop as rework and penalties due to non-compliance reduce and efficiencies increase.
